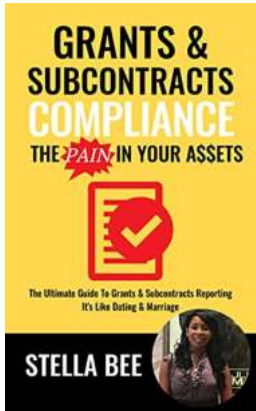

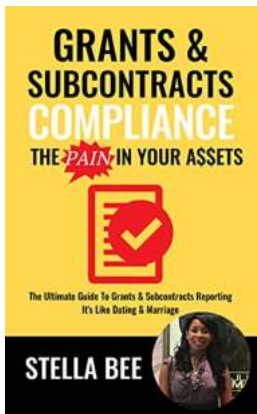

Perhaps an organization has tried a few heavy hitter grants in the past that became a real compliance pain in the A\$\$ets nightmare and are apprehensive of trying again.

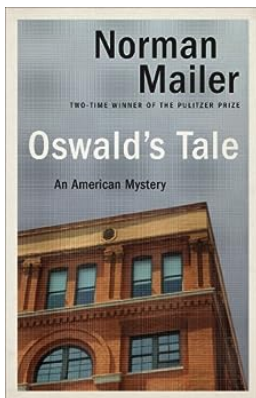

Indeed, you will start to learn financial voucher reporting like the back of your hand like I've groomed over the years very well.

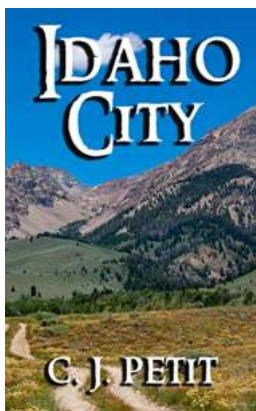
