Political Map (Sen. Hise 10/



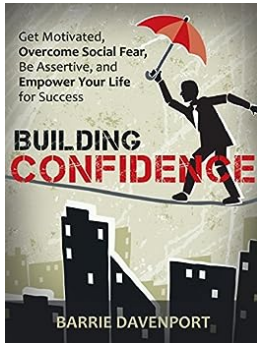
