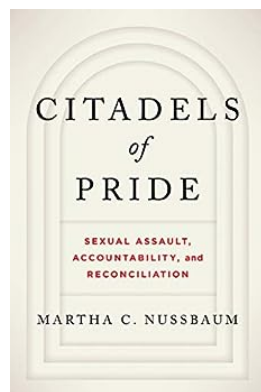
an understanding of the distorted emotions that breed abuse; and why anger and vengeance rarely achieve lasting change.
